

# Steps for EPS-95 enhanced pension-filling forms

## For retired employees:

- Go to site **sahyog.bokarosteel.in**. It is a desktop version.
- Go to EPS-95 tab
- Click on 'employer's certificate' and download it.
- To download Employee's undertaking, Click on 'employee's undertaking' and login with staff no. and date of birth.
- Enter your mobile no., email id, PPO no., and current address. Click on submit. Data once submitted, cannot be reset.
- An undertaking will be generated, download it,
- Print both employer's certificate and employee's undertaking, sign it, to upload at EPFO [website](#).
- Then go to EPFO site at the URL <https://unifiedportal-mem.epfindia.gov.in/memberinterface>
- Click on exercise of joint option
- Put UAN, Name as per UAN/Aadhaar, Date of Birth as per UAN, Aadhaar Number, Mobile number Linked to Aadhaar, then Click Get OTP.
- Click on validate OTP
- Tick the Check Box under Disclaimer
- Details will get auto Populated, optional details which are blank, if available with Employee can be also filled, put personal email ID & Aadhaar linked Bank Account Number and IFSC Code.
- Click YES in point 1, 2&4. Upload employer's certificate in Point 1 & 2, Click NO in point 3, and upload 'undertaking' in point 4.
- Enter Place & click 'I agree'. Enter [Captcha](#) and click 'Submit application'.

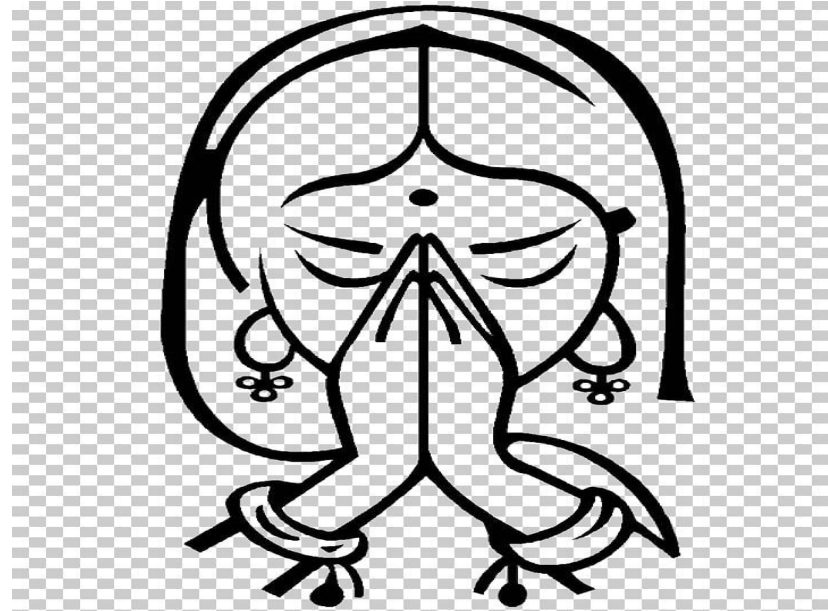
